 - (1) April 20-22, 2018: Evaluation Period
 - Evaluations permitted at certified nonscholastic events only.
 - (2) May 7-13, 2018: Recruiting Shutdown (Change effective with adoption of Proposal No. 2017-23)
 - No form of recruiting [e.g., contacts, evaluations, official or unofficial visits, correspondence or making/receiving telephone calls] is permissible.
