**INFORMATIONAL ITEMS.**

**1. Review Student Records Review Committee's December 2015 Teleconference Report.**

The committee approved the report from its December 4, 2015, teleconference.

**2. Statistics and Resources.**

The committee reviewed 2015-16 statistics, validity review examples and 2016-17 prospective student-athlete review resources. The committee noted the increase in canceled test scores arising from inquiry submission during 2015-16, as compared to prior years.

**3. 2016-17 Operational Documents.**

The committee reviewed and approved the 2016-17 PSA review trigger list, PSA review directive and committee policies and procedures. The committee noted the importance of ensuring flexibility to submit an inquiry to the testing agency based on information received regarding potential inaccurate, false or misleading activity, even if a data-based test-score trigger is not met.

**4. Legislative Proposals.**

The committee received an update regarding pre-enrollment academic misconduct legislation. During its February 2016 meeting, the NCAA Division I Committee on Academics recommended sponsorship of a pre-enrollment academic misconduct proposal in the 2016-17 legislative cycle, contingent on adoption of the post-enrollment academic misconduct proposal (2015-66). Further, the committee received an update regarding Division I Proposal No. 2015-54, which would require the NCAA Eligibility Center to receive an official transcript for each high school attended through the most recently-completed term before an institution may provide a written offer of athletics aid to a PSA.
