- **Sport and rules committee appointments.** The Division II Championships Committee approved the following recommendations from the Division II Nominating Committee regarding sport and rules committee appointments, effective September 1, 2017, unless otherwise noted.
 - a. Men's and Women's Cross Country Committee. Appoint **Alexandra Eaton**, associate director of athletics, University of Southern Indiana; and **Shawn Green**, assistant director of athletics, Southern New Hampshire University. (Note: These appointments complete the roster for the newly created Division II Men's and Women's Cross Country Committee that becomes effective September 1, 2017.)
