**Abstract**

Richard D. Schultz served as the second NCAA executive director, October 1987 through May 1993. Schultz resigned as executive director following an investigation of improper loans to student-athletes at the University of Virginia when he was the athletic director there. Correspondence consists largely of letters written to Schultz and by Schultz in his capacity as NCAA executive director.

## Biographical Note

Richard D. Schultz was selected as the second executive director of the NCAA, upon the retirement of Walter Byers in the fall of 1987. Before going to Virginia in 1981, he was the Athletic Director at Cornell University. He also held positions in athletics administration and served as head basketball coach for the University of Iowa.

Schultz received his B.S. degree in physical education and history from Central College (Iowa) in 1950 and his M.A. degree from the University of Iowa. He also received an honorary doctorate from Central College in May 1987.

Before becoming executive director, Schultz was very involved with the NCAA, serving as a speaker for the NCAA Professional Development Seminar, chairing the Marketing Committee and was a member and chair of the Division I Men's Basketball Committee. In 1987, he also chaired the NCAA Television Negotiations Special Committee.

Schultz oversaw many changes in the NCAA including growing revenues to the membership trust from the CBS Sports contract and a strong push for gender equity in college sports. Schultz resigned as executive director in May 1993.
