



# Postgraduate Scholarship Program

## SCHOLARSHIP POLICIES for FULL-TIME ENROLLMENT

1. It is understood that the recipient has completed intercollegiate athletics eligibility and competition in the sport for which the NCAA Postgraduate Scholarship was received according to NCAA regulations. If the recipient's athletics eligibility status changes, the NCAA Postgraduate Scholarship liaison at the NCAA national office must be notified immediately. If compliance with these requirements is not followed, the scholarship may be forfeited. The scholarship may not be used until all athletics competition has ceased.
2. The recipient of an NCAA Postgraduate Scholarship is required to enroll as a full-time student in a graduate degree program at an academically accredited graduate or professional school **within one-year after the academic year the scholarship was awarded**. The NCAA Postgraduate Scholarship funds are intended only for graduate courses that will apply toward completion of the graduate degree program.
3. The one-time **\$10,000** award will be paid to the graduate or professional school of the recipient's choice. The funds will be distributed at the discretion of the institution, as long as they are used to pay expenses of the student's graduate education, to include such related activities as research and teaching. Other expenses include, but are not limited to, tuition, fees, room, board, required course-related supplies and books. [*NOTE: room and board may include off-campus housing.*]
4. If the student withdraws from the institution before the entire award has been used, the unused portion of the scholarship is to be refunded to the NCAA national office for return to the NCAA Postgraduate Scholarship fund.
5. A student who desires to change a graduate program or transfer to another academically accredited institution is entitled to use any funds remaining of the NCAA award at the institution or program to which the individual transfers. Upon certification of enrollment at the subsequent institution, the NCAA will issue the remaining funds received from the original institution from which the student transferred.
6. It is permissible for the recipient to use funds from other scholarships and at the same time use an NCAA Postgraduate Scholarship award; however, an awardee may not use more than one NCAA award toward.
7. An NCAA Postgraduate Scholarship may be used at a foreign institution.
8. Funds will not be advanced to the graduate institution until certification of enrollment is received in the NCAA national office. If a recipient postpones graduate enrollment in order to complete undergraduate work, the scholarship check will not be sent until the graduate institution confirms that the student is enrolled in full-time graduate study.
9. It is the award recipient's responsibility to keep the NCAA Postgraduate Scholarship liaison apprised of any plans to delay use of the scholarship award or to relinquish any portion of the award. It is also the award recipient's responsibility to keep the NCAA Postgraduate Scholarship liaison updated of their current contact information.

## SCHOLARSHIP POLICIES for PART-TIME ENROLLMENT

2. It is understood that the recipient has completed intercollegiate athletics eligibility and competition in the sport for which the NCAA Postgraduate Scholarship was received according to NCAA regulations. If the recipient's athletics eligibility status changes, the NCAA Postgraduate Scholarship liaison at the NCAA national office must be notified immediately. If compliance with these requirements is not followed, the scholarship may be forfeited. The scholarship may not be used until all athletics competition has ceased.
3. The recipient of an NCAA Postgraduate Scholarship is required to enroll as a part-time student in a graduate degree program of an academically accredited graduate or professional school **within one-year after the academic year the scholarship was awarded**. The NCAA Postgraduate Scholarship funds are intended only for graduate courses that will apply toward completion of the graduate degree program.
3. The **\$5,000** award will be paid to the graduate or professional school of the recipient's choice. The funds will be distributed at the discretion of the institution, as long as they are used to pay expenses of the student's graduate education, to include such related activities as research and teaching. Other expenses include, but are not limited to, tuition, fees, room, board, required course-related supplies and books. [*NOTE: room and board may include off-campus housing.*] The NCAA will distribute an additional **\$5,000** to the graduate institution. upon verification the recipient is enrolled for another semester.
4. If the student withdraws from the institution before the entire award has been used, the unused portion of the scholarship is to be refunded to the NCAA national office for return to the NCAA Postgraduate Scholarship fund.
5. A student who desires to change a graduate program or transfer to another academically accredited institution is entitled to use any funds remaining of the NCAA award at the institution or program to which the individual transfers. Upon certification of enrollment at the subsequent institution, the NCAA will issue the remaining funds received from the original institution from which the student transferred.
6. It is permissible for the recipient to use funds from other scholarships and at the same time use an NCAA Postgraduate Scholarship award; however, an awardee may not use more than one NCAA award toward.
7. An NCAA Postgraduate Scholarship may be used at a foreign institution.
8. Funds will not be advanced to the graduate institution until certification of enrollment is received in the NCAA national office. If a recipient postpones graduate enrollment to complete undergraduate work, the scholarship check will not be sent until the graduate institution confirms that the student is enrolled in part-time graduate study.
9. If the recipient commences enrollment as a full-time graduate student in a graduate degree program of an academically accredited graduate or professional school **within one-year after the academic year the scholarship was awarded**, the remaining \$5,000 will be distributed immediately. It is understood that full-time scholarship and enrollment policies will apply.
10. It is the award recipient's responsibility to keep the NCAA Postgraduate Scholarship liaison apprised of any plans to delay use of the scholarship award or to relinquish any portion of the award. It is also the award recipient's responsibility to keep the NCAA Postgraduate Scholarship liaison updated of their current contact information.
